### Treasurer's Report

Ann DeLuca was not present but sent the following report.

#### Revenue:

Total Revenue year to date is \$33,000. Without the NYE Fireworks donations of \$13,500, revenue is \$19,500, which is 26% of the 2018 Budget of \$75,000. Compared to this year's current revenue of \$19,500 (without Fireworks), variance is due to the prior year Sponsor revenue that we received in 2018. (Conti \$10,000, Joe's \$5,000, Century \$1000, Prince \$500, Lewis \$500).

General Membership revenue year to date is \$851 which is 5% of 2018 budget of \$18,000. Prior YTD was \$1,370.

#### Expenses:

Program Related Expenses year to date are \$7,700. Without the NYE Fireworks of \$1,030, Program related expenses are \$6,600, which is 8% of the 2018 budget of \$83,500. Prior year program related expenses were approximately \$1,700. Variance mainly due to the prior year Park Ranger expense of \$1,355 that we just received in 2018 and the Trellis lights of \$3,600

### Fundraising report - Patricia Sabbey

Patricia was unable to attend and sent the following report:

Horticulture report - Robyn Reed

On March 18 we had a wonderful pot luck get together, complete with medals for the Horticulture volunteers and we planned our upcoming season. We are very excited for spring!

We have started our garden meeting times for the year, although the weather is not cooperating. We started cleaning the Crescent garden of the debris and weeds but we are not able to trim back the rose bushes yet because it is too cold for the roses.

We are keeping the same schedule as last year:

- o Wednesdays 6-7pm
- o Thursdays 8:30 to 9:30am
- o Sundays 9:30 to 11:00am

We have asked the City to cut back the grasses in the Crescent.

We have contracted with Schumacher Landscaping to remove the roses from the side beds of the rose garden and replace the old roses with new Double Red Knock Out roses. The Horticulture group has decided we need to remove the roses because of the extensive root damage made by the rats, and replace them with new, easier to care for roses. They will start as soon as the weather and their schedule allows.

Everyone is welcome to join us – we will train you and provide you with all the tools and gloves. Please just wear closed-toe shoes and appropriate clothing, as well as sun protection.

I am starting to plan the summer art projects, and my theme right now is “Birds, Bees, Bats and Butterflies”. If anyone has any comments or suggestions or ideas, please contact me. I am waiting on permission from the Park Dept to install bat houses and birdhouses in the park and we will be planning a few more plants specifically to attract these creatures in the park. My inspiration for the art project is M.C. Escher’s “4 motifs” ( Robyn showed copy of this work) but I do not have specifics about the materials or designs yet. I do hope to make the bird and bat houses out of discarded wood pallets. Robyn may try to link this effort to the Greenway “insect hotel” project

Joanne also reports that as a result of recommendations from the horticultural lecturer last year, there have been discussions with Chris Cook about the longstanding Oasis Project. The area needs the soil removed and rat grate installed. There are some FOCCP funds for this. She is discussing the possibility of city watering trucks also watering the oasis garden as they water hanging plants around d the city. Maybe we could link some garden improvement to the new business membership project - tying specific businesses to specific improvements. Joanne will also speak to Chris about the tree that fell over in the storm.

Robyn reported that the organization, Save the Harbor, Save the Bay, is sponsoring a pop-up museum in the 1st floor of the Strada Bldg. The “Changing Course” sculpture will go on display again. Congratulations, Robyn

### **Elections & Annual Meeting.**

The Annual Meeting will be held the May meeting during which time the election for officers and directors-at-large will be held.

The officers are President, Vice President, Treasurer and Clerk and there are 2 at large-positions.

### From the FOCCP bylaws:

- Members in good standing who wish to run for election to Officer or a Director-at-Large position shall nominate themselves by submitting a nomination statement in writing to the Clerk filed no later than fourteen (14) days prior to the annual Membership Meeting - **Tuesday, April 24, 2018**. Requests to be nominated shall be no longer than one page and shall include the member's name and address, and may optionally include a statement by the member in support of his or her candidacy.

- Copies of all nomination statements received by the Clerk at least fourteen (14) days prior to the Annual Membership Meeting shall be included with the notice of meeting sent to members - the newsletter of **Tuesday, May 1, 2018**.
- Nominees are not required to be present at the Annual Meeting; however, any nominee present may make a brief (two minute) statement to the members present. For those nominees not present, the Clerk shall read to the membership the written statement submitted, if any, by the candidate for his or her nomination.
- A preprinted ballot of only nominee names shall be used at the Annual Meeting, and the ballot shall be cast in secret and placed in a box provided by the Clerk before being counted.
